## DuQuoin International Meetings Report

### June 30 Delegates Meeting

Prior to the Delegates Meeting, International President Norm Beu withdrew his motion to introduce the proposed revised constitution. The motion will be re-introduced at the 2012 Delegates Meeting. The proposed revised bylaws will be released to the membership soon so that members can discuss the revisions as a complete package.

An amendment to the Constitution requiring the Nominating Committee to publish the position papers of all qualified candidates in the April issue of the Blue Beret, not just those selected by the Committee, passed with 96% of the votes in favor.

There were no international officer nominations from the floor and the Nominating Committee's slate of officers was accepted. John Stumpf, Past President of Region 6, was elected Third Vice President.

During discussion of the proposed revised constitution at the Delegates Seminar, Delegates overwhelmingly supported maintaining the Delegates Meeting and showed little support for the proposed replacement of the Delegates Meeting with a member caucus. It seems likely that the revised constitution will be amended accordingly at next year's Delegates Meeting.

### June 27 and July 5 IBT Meetings

A motion was approved to present a constitutional amendment to the Delegates on the 2012 ballot which reads: "Regular members who are Life Time Members may, upon request, retain their membership as Regular Members if they replace their Airstream manufactured recreational vehicle with a Class A motor home manufactured by a division of Thor Industries, Inc., the parent company of Airstream, Inc."

A motion was approved to amend the Bylaws to permit the nomination and election of individuals who have previously held a region office, but not serve consecutive terms. A separate motion was approved whereby the current Region President may appoint the Region's Immediate Past President to serve on the region board.

A balanced budget for the fiscal year ending 2012 was achieved when a motion was approved to acquire a cost savings of \$11,400 for printing and postage by eliminating the December Blue Beret and to change the format of the directory similar to the Blue Beret but with a heavier cover than the magazine.
